I hereby authorize the Court to conduct a **Trial in Absentia** should I fail to appear at the proper date and time set for my court trial. In other words, my trial may be heard without my personal appearance should I fail to appear. Furthermore:

1. I specifically waive any obligation the Court may have to make finding as to whether my absence was voluntary; and
2. If I am found guilty, I specifically agree that the Court may pronounce immediate sentence, waiving any right to a delay of sentencing from 6 hours to 5 days

**The initial fine is comprised of the base fine, plus a \$10 enhancement for each prior conviction (if any), plus state and county penalty assessments,, a \$35 conviction fee for every convicted count plus \$4 for Emergency Medical Transportation fee for each Vehicle Code violation and any delayed payment/installment charges.**

**Also, pursuant to PC1214.1, in addition to any other penalty in infraction cases, the court may-impose a civil assessment of up to \$100 against me add a new charge for failure to appear and refer my case to collections if I fail, after notice and without good cause, to appear in court for any proceeding authorized by law or if I fail to pay all or any portion of a fine ordered by the court.**

A failure to pay (FTP) situation will exist if I fail to pay the total penalty and/or late charge, the court may then impose a civil and may then refer the matter to collections.
